Annex 1 to FIBA 3x3 Handbooks

Fees, Fines and Sanctions Catalogue

(valid as of 15 February 2024)

FIBA may apply the following standard set of administrative fees, fines and sanctions for infractions and violations of the regulations of the respective competition handbooks, i.e. National Team Handbook, Men Pro Circuit Handbook and Women’s Series Handbook (“Handbooks”):

1. **Administrative fees**
2. **Fines & sanctions for participation-related violations**
3. **Fees, fines and sanctions for uniform and ancillary gear/equipment related violations**
4. **Additional billed services upon team request**

Note:

The definitions of the respective Handbook apply. This Annex must be read in conjunction with the corresponding Handbook. In case of any discrepancy between the respective Handbook and this Annex, this wording and amounts of this Annex shall prevail.
